### **CGS 3528 Non-Hegemonic Food Economies**

The calendar description for this course reads as follows: “An examination of the persistence, resurgence, and radicalization of modes of producing and consuming food in a context of hyper-capitalized and globalized food regimes. This course examines food-based economies foundational to a variety of social movements aimed at establishing and re-establishing forms of local and relational autonomy.”

Centre for Global Studies students will immediately recognize this orientation, to focus on people’s activities and endeavors under less-than-sufficient circumstances, to move the innovation, creativity and insight generated in the life of the community into the foreground. In this case, we are drawing our focus on activities that provision households and the networks they sustain and are sustained by. We will examine food provisioning as a medium to produce strength under conditions that are often threatening.

### **Learning Objectives**

Students will exercise close reading skills, critical analysis of a range of disciplinary and interdisciplinary readings, analyse visual materials, and practice skills of listening and responding in a seminar setting. Overall, these are the advanced scholarly skills suitable to rigorous interdisciplinary study.

### **Class Methods**

Your course materials will be lectures, readings, some films, and discussion questions assigned for readings. Please be prepared to read 40-60 pages per week, much of it very accessible, and likely enjoyable. As these readings are the basis of your papers, you are doing ‘all’ of your course work by reading them.

We will meet each week, I’ll lecture and ask questions, you’ll answer questions and ask questions, and all of this is directed to ensuring you are well-prepared to write your response papers, to prepare answers to core questions about the purpose, constitution and standing of non-hegemonic food economies. It’s all directed to the content of those papers.

### *Attendance*

This is straightforwardly that your 10 points are reduced by 1 point for each unexcused absence.

### *Participation*

Each week you will find a reading and a set of discussion questions on OWL under our 'Lessons' tab, each week numbered as in the work schedule below. Some weeks' readings are very long, so please check well in advance of class and give yourself sufficient time to prepare in advance for class. I promise our discussions will be engaging and there will be lots of prompts to get you involved.

### *Response Papers*

You will prepare four short essays for this course, all on assigned readings. Each will be 6-8 pages, 1,500-2000 words. Style requirements and all other instructions are on OWL. All papers will be responses to questions I pose.

The format of the response paper is that it should be a straightforward answer to the questions/draw a conclusion if I ask, using lots of specific references and details from the section of course readings we're examining. Each of the first three papers will respond to the titles of our weekly meetings (see below). The final, fourth, 'take home exam' style paper will ask you to draw some broader conclusions about the core themes of this course. (Those core themes are power, social reproduction and resistance. When aren't those the core themes?)

### **Prerequisite and Antirequisite Information**

### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

### **Statement on Use of Personal Response Systems (“Clickers”)**

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else’s clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

### **Academic Consideration for Missed Work**

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

### **Policy on Academic Consideration for a Medical/ Non-Medical Absence**

- (a) Consideration on **Medical Grounds** for assignments worth *less than 10%* of final grade: **Consult Instructor Directly and Contact Academic Advising**

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the [Student Medical Certificate](#). The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

**b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising**

University Senate policy, which can be found at [Academic Calendar - Western University \(uwo.ca\)](#) requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: [https://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/medicalform.pdf](https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf).

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

**c) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email [huronsss@uwo.ca](mailto:huronsss@uwo.ca)**

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed [Consideration Request Form](#). Late penalties may apply at the discretion of the instructor.
