# **Course Description:**

This course is a survey of the major themes in the Chinese short story from the Han dynasty to the Qing dynasty. It examines selected works that are written in classical and vernacular languages and represent a variety of narrative forms. The approach employed to investigate the selected works is the intrinsic or literary approach that focuses on the examination of plot construction, characterization, narrative stance, and techniques and strategies of meaning formation in the texts. The course is taught in English.

# **Learning Objectives:**

By the end of this course, students will be able to

- 1. Outline the major developments in the history of the Chinese short story in traditional Chinese literature;
- 2. Identify main genres, important works, major authors, and their contribution to the development of the Chinese short story;
- 3. Describe the common and unique narrative methods and techniques in story-telling;
- 4. Develop analytical skills and critical thinking abilities in studying traditional Chinese fiction.

## **Textbooks and Other Required Resources:**

Readings will be offered by the instructor.

## **Class Methods:**

Classes will be offered in person.

#### **Methods of Evaluation:**

Attendance and Participation: 10%

Midterm Test: 25% Final Test: 30%

Presentations and follow-up paper: 30% One Forum posting 5%

# Attendance and Participation

Simply coming to the class without further commitment to class activities is still far from enough. Besides regular attendance, your active in-class participation is required. You should read the assigned texts and come to class prepared for class discussion.

## **Tests**

The mid-term test will be scheduled in the middle of this term. It is two hours in length and covers lectures and readings before the exam. The final exam will be scheduled during the exam period. It will cover lectures and readings after the mid-term test. The exam format will be given in class before the exam.

# Presentation and Follow-up Paper

Students will sign up for the session where they plan to do their presentation. You should prepare a short oral presentation and lead in-class discussions. The total presentation & discussion time is 15 minutes. You are required to submit a follow-up paper one week after your presentation, which outlines your presentation by following the academic format. A strong follow-up paper has a defensible argument, which is further unpacked and supported by the rigorous analysis of evidence. The presentation/follow-up paper should not simply summarize the text or introduce some background. Rather, it shows your ability to analyze the narrative in relation to existing themes. Specific instructions for the presentation and follow-up paper will be provided in class.

# One online posting

This assignment tests your ability to critically engage and analyze the text. You should find an excerpt from the class materials and make an active reading of the selected texts. You may also bring in external sources to help achieve the goals. Examples will be given in the class. Length: 500 words.

# **Special Instructions**

There is a penalty for the late submission of the electronic copy of the paper. The penalty is 10% for each calendar day to a total of three days.

There is no make-up exam, except in the case of documented medical or compassionate circumstances.

# Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clicker records are used to compute a portion of the course grade:

#### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
