

Course Description:

This course immerses students in the study of a variety of contemporary graphic narratives with the overall objective of becoming better students of image-text meaning-making practices. To this end, our course engages with comics and graphic fiction scholarship from around the globe. We will apply a range of perspectives, looking at specific kinds of cultural, historical, and formal relationships.

We will also examine the multimodal elements of graphic texts – their potentials and their controversies – and we will ask how they challenge us to consider broader questions about accessibility and activism, memoir and literature, and the sometimes "invisible" yet highly impactful powers of reframing cultural and individual storytelling practices and in what ways.

*** Please note that this is an interactive course. This means that the course requires your participation in both in-class and out-of-class assignments. Your involvement in all aspects of 2091F is the key to your success in this course. Course Learning Objectives:

Through regular participation, by the end of this course, students should not only be better students of graphic fiction, but they should be able to

- ➤ employ the critical vocabulary of comics and graphic narrative and discuss key concepts at the intersections of comics studies and graphic storytelling.
- identify and contextualize specific techniques, assumptions, and themes in graphic texts.
- recognize how graphic narratives are distinct from—yet also connected to—other cultural forms, such as visual art, and film and their broader historical contexts.
- improve abilities to construct concise, persuasive arguments through practicing a variety of critical evaluations and interpretive analysis.
- > source and analyze relevant critical sources and secondary research in support of original ideas and research creation.

Breakdown of Marks:

All assignments will be accompanied by detailed instructions and discussed in class, week one.

- 1) Class Quizzes (best 5 of 6 first 5 marks returned by November 7): 20%
- 2) Formal Essay, Traditional (in MLA format), or Graphic-Essay hybrid (examples will be provided), due by **November 30**: 20%
- 3) Research Presentation (Week 11 & 12): 20%
- 4) Attendance and participation: 10%
- 5) Final Exam (TBA): 30%

Pandemic Contingency

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (http://www.turnitin.com).

Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect

documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

<u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
