2. Course Description

Through the study of the cultural productions from the 20th Century in France, students will deepen their knowledge of specific productions as well as of critical approaches to them in order to be able to formulate their own critical perspectives and to communicate them effectively and accurately orally and in writing.

Ce cours aura pour objectif d'offrir un panorama du vingtième siècle français, en articulant productions artistiques, moments historiques, mutations sociales et tournants politiques. L'angle choisi est celui d'une histoire des productions culturelles (arts plastiques, littérature, cinéma, musique) et des idées prise dans une « histoire monde ». Nous reviendrons sur un siècle de mutations artistiques, culturelles et sociales dans une France qui n'échappe pas aux influences du monde car elle est en partie intégrante par son histoire contemporaine (Empire colonial/décolonisation, guerres mondiales, construction européenne...).

3. Course Learning Outcomes

1. Les étudiants auront acquis une compréhension générale de l'histoire de France au XXième siècle en la reliant systématiquement aux phénomènes littéraires et artistiques.
2. Les étudiants seront placés en position de témoins directs, comme lecteurs ou observateurs de certaines productions artistiques pour les amener à apprécier d'un œil nouveau les richesses d'une civilisation dont nous sommes encore très largement les héritiers.

3. Ils/elles seront aussi acteurs et actrices de la classe en produisant des exposés thématiques qui complèteront les savoirs.
4. Ils et elles amélioreront la maîtrise du français à l'oral et à l'écrit à travers la lecture d'articles, d'extraits d'œuvres littéraires et le commentaire de documents divers.

4. Textbooks and Course Materials

Texts and course materials will be provided by the instructor and available in OWL.

5. Methods of Evaluation/ ÉVALUATIONS

- Présence et participation active en classe :	10%
- Exposé en classe :	25%
- Deux travaux écrits en classe :	30% (15 X 2)
- Travail final écrit à la maison (take home exam) :	35%

Présence et participation active en classe: la présence en cours et la participation active en classe seront évaluées. **10%**

Exposé : Chaque étudiant(e) choisira un sujet d'exposé dans la liste présentée (**see appendix 1**) dans le premier cours. Il/elle présentera en français à la classe le sujet en 20/30 minutes, à l'aide des ressources de son choix (youtube, power point, extraits de chansons, de films, de documentaires, etc...). **25%**

Travail en classe 1 : A l'aide du dossier pédagogique et de la présentation consacrés à l'exposition de peintures, «Chagall, Modigliani, Soutine, Paris pour école : 1905-1940 » (documents disponibles au format PDF sur OWL), chaque étudiant devra répondre à une série de questions sur les œuvres de ces artistes et leur contexte de création. Le dossier pédagogique sera disponible en ligne dès le début de la classe. **15%**

Travail en classe 2 : A l'aide de courts textes des philosophes Jean-Paul Sartre et Albert Camus, chaque étudiant(e) répondra à quelques questions sur la philosophie de l'existentialisme et sur le concept de liberté chez ses deux auteurs. **15%**

Travail final à la maison (Take home exam) : Dans un essai de 2000 mots, chaque étudiant(e) traitera d'un sujet à choisir parmi deux options (un essai de synthèse ou une analyse de texte).

- 1) Il/elle présentera les enseignements les plus intéressants d'un thème vu en classe (événement historique, mouvement littéraire ou artistique, etc), exposera les raisons de son choix.
- 2) Il/elle sélectionnera un texte littéraire, journalistique ou historique, une œuvre artistique (film, musique) de son choix et en proposera une analyse. **Le choix devra être discuté et validé par l'enseignant avant la fin de la classe.** **35%.**

Appendix to Course Outlines: Academic Policies & Regulations 2021 - 2022

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Pandemic Contingency

In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, all remaining course content will be delivered entirely online, typically using a combination of synchronous instruction (i.e., at the times indicated in the timetable) and asynchronous material (e.g., posted on OWL for students to view at their convenience). Any remaining assessments will also be conducted online at the discretion of the course instructor. In the unlikely event that changes to the grading scheme are necessary, these changes will be clearly communicated as soon as possible.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<http://www.turnitin.com>).

Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

Statement on Use of Personal Response Systems (“Clickers”)

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must

see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_illness.pdf are met.

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. Policy on Academic Consideration for a Medical/ Non-Medical Absence

**(a) Consideration on Medical Grounds for assignments worth *less than 10%* of final grade:
Consult Instructor Directly and Contact Academic Advising**

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the [Student Medical Certificate](#). The instructor **may not** collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

(b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email huronsss@uwo.ca.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed [Consideration Request Form](#). Late penalties may apply at the discretion of the instructor.
