#### 2.0 COURSE DESCRIPTION

Conversation-based, group-oriented experiential approach to Japanese. Conducting theme-based tasks in Japanese, students improve their conversational proficiency, as well as expanding practical vocabulary of Japanese. Taught in Japanese.

#### 3.0 COURSE LEARNING OBJECTIVES

This course aims to help students:

- To acquire more advanced communicative skills (speech and listening) of modern Japanese, with a particular emphasis on the spoken language.
- To acquire knowledge about Japanese culture through verbal communication and its mannerisms.
- To acquire and manipulate linguistic signs for communication.
- To strengthen conversation skills for intermediate level students (e.g. JPN3350 and 4450).

#### 4.0 DESCRIPTION OF CLASS METHODS

Using the *Marugoto* textbook, the objective of this course is for you to be able to communicate at the B1 level in Japanese. B1 is a level where you are able to talk coherently, understand the important points of texts on familiar topics, and deal with a range of situations by yourself while travelling in Japan. The course will cover from Topic 6 to Topic 9, including additional materials that I consider are relevant. Since the course will center on 'speaking', we will mainly use parts: Preparation, 1, 2 and 3.

This course will be conducted in a communication based language instruction with the primary emphasis on Can-do statements. Through this course, little by little, you will be able to increase the number of 'things you can do in Japanese'. The majority of the class time will be spent on

the students' speaking the language in class. Therefore, it is very important for each student to come to class thoroughly prepared.

#### 4.5 EXPERIENTIAL LEARNING

You will be assigned one or two Japanese students to practice your Japanese. You will discuss what you would like to research with your partners for your in-class presentation.

The discussion with your partners should be one hour (max.) every week during February to March. It can be done synchronically or asynchronically. You need to write three progress reports (your short reflections) on the OWL forum.

- 1. Class participation (15%). This includes class presentation, presentation progress reports and homework. Class performance of each class will be graded between 0-5 and -1 for an absence without a proper excuse. For an absence, you can watch recorded lectures and submit your performance video through Voicethread (OWL). Please name the video file to include the date of your missed lecture.
- 2. Small speech drafts (10%). Your speech draft should be submitted through Assignments in OWL.
- 3. Topic quizzes (10%). Quizzes take place after you have finished one topic. However, the last topic will be covered in the final exam.
- 4. Oral interviews (30%). Two interviews will be scheduled.
- 5. Presentation (15%). This includes your written version and class presentation. You will pick one topic regarding Japanese culture. Research with your assigned partners and present your findings in class.
- 6. Final exam (20%).

- \* Your performance will be assessed based on your language level according to the OPI scale. For example, JPN3350 students are considered as intermediate-mid/high while JPN4450 students are intermediate-high/advance-low.
- \*\*This course follows Western's grading guidelines.
- A+: One could scarcely expect better from a student at this level. (i.e. One's performance is in the competitive level at the Ontario Japanese Speech Contest.)
- A: Superior work which is clearly above average.
- B: Good work, meeting all requirements, and eminently satisfactory.
- C: Competent work, meeting requirements
- D: Fair work, minimally acceptable
- F: Fail

#### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

#### **Conduct of Students in Classes, Lectures, and Seminars**

Personal Response Systems ("clickers") may be used in some classes. #### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic policies/appeals/Academic Consideration for absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf.

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

# Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will
  require students to present a <u>Student Medical Certificate (SMC)</u>, signed by a licensed medical or
  mental health practitioner, detailing the duration and severity of illness, or appropriate
  documentation supporting extenuating circumstances to the Academic Counselling unit in their
  Faculty of registration no later than two business days after the date specified for resuming
  responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the
  period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil
  the academic expectations they may have missed during the absence.

# Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

(a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

University Senate policy, which can be found at,

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of

the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

#### (c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <a href="Accommodation Request Form">Accommodation Request Form</a>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to

complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
