Description

Perhaps no era has produced more geniuses and polymaths, or has more profoundly shaped the world, than the 17th and 18th centuries. In this course, we will critically examine selections from six canonical philosophical works of this period:

- René Descartes, *Meditations on First Philosophy* (1641),
- Gottfried Leibniz, *Discourse on Metaphysics* (1686),
- John Locke, *An Essay Concerning Human Understanding* (1690),
- George Berkeley, *A Treatise Concerning the Principles of Human Knowledge* (1710),
- David Hume, *An Enquiry Concerning Human Understanding* (1748),
- Mary Wollstonecraft, *A Vindication of the Rights of Woman* (1792).

Along the way, we will explore some influential critiques of these works by Princess Elisabeth of Bohemia, Lady Anne Conway and Thomas Reid. No background in Early Modern Philosophy is expected or presupposed. Also, for some portions of these writings, students will receive guidance from contemporary commentators, e.g. Namita Nimbalkar.

Methods

Teaching methods will involve pre-prepared slides, with recorded commentary, and live virtual class discussions (e.g. tutorials, workshops and various exercises).

This fully online course will contain a mixture of synchronous and asynchronous learning methods. Synchronous (i.e. live) sessions will ordinarily take place within the Friday time window above. Students will be given material to prepare for those sessions, at their own discretion; however, it is recommended that they use the Wednesday window above to prepare.

Aims

By the end of the semester, students will

1. be acquainted with some of the major metaphysical and epistemological controversies of the 17th and 18th centuries (**KNOWLEDGE**); these include
 - controversies over the nature and existence of God, what sort of thing the human mind is, how it persists in (and relates to) a physical world and, indeed, whether there is a physical world
 - controversies over the nature and possibility of human knowledge, the rationality of belief in miracle reports, decisions under uncertainty, the theme of “enlightenment” and the intellectual significance the so-called principles of “Common Sense”
2. have presented and defended their own thoughts on these controversies (**PERSONAL DEVELOPMENT**);
3. have cultivated intellectual virtues pertaining to argumentation, dialogue, interpretation, research and clear writing (to help with outcomes 1-3) (**SKILLS**).

Podcast: In recognition of Banned Books Week (Sep 27-Oct 3), you will work in small groups (approx. 4 students, including a moderator) to critically discuss one feature of an early modern text that was banned, i.e. listed on the *Index Librorum Prohibitorum* (e.g. Descartes' *Mediations*). To ensure that all students are available, each video or audio podcast will be recorded, over Zoom, within the 9/25 class meeting window. Advanced planning, prior to the brief podcast recording, is recommended. To encourage this, I will provide group numbers and instructions ahead of time. Note: if you are uncomfortable with facial presentation, you may mute your webcam. Also see the red note below.

Paper: Instructions will be made available during our workshop on how to write a philosophy paper.

Participation: Good philosophy requires conversation. Consequently, in addition to prepared materials/slides/recordings that you will review on your own time, this course contains weekly live sessions (e.g. tutorials, workshops and surprise group exercises, written and/or verbal), which will take place over Zoom. Camera shy? Please take full advantage of other participation modes (e.g. forums, mini-assignments and exchanges with group members with Zoom's breakout function etc.)

- **Note:** if you are working in a different time zone, and are unable to attend our live online sessions, please note this in OWL's DropBox, during the first week of class, by writing “Opt-Out Request for Online Participation” in the subject title. I would be pleased to fully accommodate you for missing assignments 1 and/or 4.

All written assignments, including your research essay, exam and surprise classroom exercises, where applicable, must be submitted through the assignments tab (on OWL).

Exam: To take place during the December examination period. As this take-home exam will be “open book”, its purpose is to test the student's understanding of major themes, arguments and positions etc. As answers to such questions cannot be unreflectively pasted from the slides, advanced preparation is strongly recommended.

Grading Information and Explanation of Grades:

Each assignment will be accompanied with clear instructions. Students will be evaluated in accordance with how well they follow them.

Appendix to Course Outlines: Academic Policies & Regulations 2020 - 2021

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

Conduct of Students in Classes, Lectures, and Seminars

Academic Integrity: Importance and Impact

Being at university means engaging with a variety of communities in the pursuit and sharing of knowledge and understanding in ways that are clear, respectful, efficient, and productive. University communities have established norms of academic integrity to ensure responsible, honest, and ethical behavior in the academic work of the university, which is best done when sources of ideas are properly and fully acknowledged and when responsibility for ideas is fully and accurately represented.

A university is a place for fulfilling one's potential and challenging oneself, and this means rising to challenges rather than finding ways around them. The achievements in an individual's university studies can only be fairly evaluated quantitatively through true and honest representation of the actual learning done by the student. Equity in assessment for all students is ensured through fair representation of the efforts by each.

Turnitin.com

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the

purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<https://www.turnitin.com/>).

Computer-Marked Tests/Exams

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Clickers

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else’s clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/Academic_Consideration_for_absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate (SMC)**, signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

Policy on “Academic” Accommodation - Medical / Non-Medical Grounds

- (a) **Medical Grounds for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email huronsss@uwo.ca .**

University Senate policy, which can be found at,

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf , requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(b) Accommodation on Medical Grounds for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed [Accommodation Request Form](#). Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
