# Description

We are going to be asking two questions:

Q1. What, if anything, do all morally "right" actions have in common?

Q2. What, if anything, do all "good" (happy, meaningful) lives have in common?

In response to the first question, we'll compare answers from UTILITARIANISM, KANTIAN ETHICS and NATURAL LAW, in Unit 1, and apply them to a number of controversies—concerning, for instance, our obligations in connection with the poor, PVS patients and non-human animals.

In Unit 2, we shall survey some recent criticisms of these traditions.

Finally, moving on to the second question, in Unit 3, we'll discuss rival accounts of well-being and related goods against the backdrop of the problems of suffering and death.

- have presented and defended their own sustained argument on a topic in ethics and/or value theory in the midst of having carefully entertained criticisms and alternative perspectives (PERSONAL DEVELOPMENT),
- 4. have cultivated intellectual virtues pertaining to argumentation, dialogue, interpretation, research and clear writing (to help with outcomes 1-3) (SKILLS).

**Applied Ethics Podcasts (20%):** This assignment (performed in small groups) is designed to encourage students to reflectively integrate course material. To ensure that all students are available, each podcast will be recorded immediately after one of our classes, which will end a bit early. Unlike some podcasts, which involve prolonged improvisation and open questions, with unspecified aims, these podcasts will need to be brief, efficient, to the point, and well-organized. **Advanced planning is, accordingly, strongly recommended.** To encourage this, I will provide group numbers, basic job descriptions and instructions ahead of time.

**Research Paper (30%):** It is important for university students to conduct their own research and advance a sustained argument, in writing, with the goal of moving a discussion forward. This is the aim of your research paper. I will provide some broad topics, but each student must come up with their own project and thesis statement. Please note: there is **only one paper per student**.

**Final Exam (30%):** Anything we cover in class, at any point, is admissible and hence a proper object of study, unless I explicitly say otherwise in writing (via OWL). Although the final exam will take place during the December examination period of 2022, the specific date has not yet been determined. Please look for that info, online, when the official exam schedule is posted by the College. Also, **be sure not to make any irrevocable travel arrangements, or plans, until you know the exam date.** The exam will likely contain some sort of combination of shorter answers and longer answer(s), though these details should not impact your preparation methods. More details will be provided during our final session.

**Active & Informed Participation (20%)** Good philosophy requires conversation. As such, the success of our weekly sessions will be largely determined by the overall quality of the comments of the participants. Students are, accordingly, expected to take active measures to advance the discussion. Such measures include:

- (a) being attentive,
- (b) knowing and thoughtfully engaging the assigned readings,
- O (c) applying the tools and virtues associated with critical thinking (e.g., careful argumentation, open-mindedness, reflective questioning, virtuous disagreement, and active listening),
- (d) following the College's student conduct requirements and any course-specific policies (see OWL), including our attendance policy as well as our strict no recording policy (which helps protect student privacy and confidentiality),
- o (e) not using one's laptop/cellphone or talking while other students are presenting ideas,
- (f) being reliably present (this includes avoiding a post-midterm attendance nosedive),
- (g) following OWL's weekly checklist religiously (which may, on occasion, ask you to submit typed questions) to help you prepare for our sessions,
- (h) submitting all required participation comments, via OWL's forum, when prompted
  - These typically 1-3 sentence assignments will be briefly worked on in class and cannot be submitted late, from outside the classroom, or by a surrogate submitter (e.g., a group member/ classmate). Nor will the questions be circulated ahead of time.

# **Grading Information and Explanation of Grades**

Each assignment will be accompanied with clear instructions. Students will be evaluated in accordance with how well they follow them. What follows is a university wide-grade explanation:

<u>Late assignments</u>: Neglecting assignments which may not be submitted late (e.g., in class-assignments and work completed after the last day of class, including your final exam), all late assignments will receive a late penalty of 5% per day, including weekends.

#### Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clicker records are used to compute a portion of the course grade:

## Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# b) <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# c) Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation.
