# Writing 2101F – Expository Writing Intersession 2022

#### 2. Course Description

An introduction to the basic principles and techniques of good writing. The course will emphasize practical work and the development of writing skills for a variety of subjects and disciplines. Using an issues-based approach, Writing 2101F teaches students to synthesize higher order scholarly thinking with writing that appeals to diverse audiences and perspectives, thus fulfilling a mandate to bridge academic discourse with the community, while encouraging students to think creatively through challenging questions.

#### 3. Learning Outcomes

Students will begin to understand the varying methods of producing expository writing, making use of techniques such as description, narration, explication, and analysis.

Students will learn to distinguish their writing voices from the voices of others while forging a connection between the two that produces cohesive academic discourse.

Students will begin to recognize and make use of various discursive strategies to produce different effects on their reading audiences.

Students will identify the ways in which writing within and across academic disciplines produces empowering and enlightening ways of thinking about social issues, community engagement, and contemporary cultures.

#### 7. Assignment Notes

Your **Writing Portfolio (30%)** is your main collection of writing throughout the course. It includes writing such as brainstorming, idea generation, your essay proposal, and in-class prompt responses.

The **Research Essay (30%)** asks you to investigate an issue arising from a topic (general topics provided), and then to defend an argument arising from that issue. You will write a brief proposal for the essay and include it in your writing portfolio.

The **Process Analysis (20%)** is a written explanation of how something works or how something happened. Topic suggestions will be provided. The **Explication (10%)** is an oral version of your process analysis, meaning you "teach" the concept of how something works or how something happened to an audience of your peers. You will sign up for an explication date no later than the end of the first week of class. The process/idea you explain should relate to the **discussion question** of the day (see schedule). I am happy to discuss ideas with you.

**Attendance and Participation (10%)** are *de facto* expectations of this course, which relies heavily on engaged discussion and debate. I monitor both in every class. Additionally, I will ask you to be self-critical by reporting to me an assessment of your contributions to the course near the end of the term—an assessment to be included in your writing portfolio.

#### 8. Instructor Policies

- Apart from the Writing Portfolio, you must submit assignments via OWL at all times.
  No email submissions are permitted. If you have doubts about or trouble with OWL
  submissions, please get in touch with me well ahead of the submission deadline and
  we can figure it out together.
- 2. When you email me, I will make every effort to respond to you within 24 hours—often much faster—between Monday and Thursday. I realize that we all work on different schedules, and I know that your email-attentive hours may differ from mine. Typically, I try to avoid responding to email on weekends, but if you need me to know something on a Saturday or Sunday, chances are I will see it. You can expect a response Monday morning. Other modes of communication work too: if you, for example, see something interesting on Twitter or Instagram, be sure to tag @profgreenway so I can see it too!
- 3. LATE POLICY: Once you have signed up for an Explication date, you are bound to it unless there is another space available, or unless someone has agreed to switch dates with you. No extensions are permitted on Explication deadlines. Other than for reasons of academic accommodation, which must be solicited through your academic advisor, all other late assignments will be penalized by 5% per day (a weekend is two days), to a maximum of seven days, at which point the assignment will not be graded. HOWEVER, if you are approaching a deadline and think you may not meet it, email me at least three days before the deadline and we can work something out. Under no circumstances will I entertain an extended deadline if you email me within three days of the deadline, or not at all. Keep tabs on yourselves.
- 4. You are welcome to meet with me in my office (A104) or over Zoom at a mutually convenient time. For this course, I will be in my office immediately following the

- Monday class. Email me ahead of time to guarantee a visit. Please use your UWO email address for all correspondence.
- 5. Writing 2101F/G is normally taught over twelve weeks, so this version is highly concentrated. I have modified it to better suit our needs, but success in the course insists upon your diligence and consistency. I promise I will work hard within my means to provide you with an exceptional experience in a Writing course at Huron! I expect you to be open and communicative with me, to energize yourselves intellectually and personally, and to take risks in your writing. I'm here to help.

#### **Prerequisite and Antirequisite Information**

#### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

#### **Statement on Use of Personal Response Systems ("Clickers")**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_illness.pdf are met.

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic

consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. #### Policy on Academic Consideration for a Medical/Non-Medical Absence

## (a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

### (b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email huronsss@uwo.ca.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <a href="Consideration Request Form">Consideration Request Form</a>. Late penalties may apply at the discretion of the instructor.
