**2.0. CALENDAR DESCRIPTION**

An introduction to method and theory in the study of human cognitive processes. Topics covered may include: perception, attention, memory, concept formation, language, thinking, problem solving, and comparative cognition. The course will involve both theory and hands-on experience with the research methods used by cognitive psychologists.

Antirequisite(s): Psychology 2135A/B

Prerequisite(s): Psychology 1100E and Psychology 2830A/B. A minimum of 60% is required in Psychology 1100E. May be taken concurrently with Psychology 2830A/B.

**3.0 COURSE LEARNING OBJECTIVES**

By the end of the course students should have:

- Knowledge of the fundamental concepts in human cognition.
- Extensive exposure to human cognition research paradigms.
- Hands-on experience in designing research projects, data collection and analysis, and preparing research reports.

## 4.0 DESCRIPTION OF CLASS METHODS

This course has two components:

- (1) lectures are designed to help students become acquainted with the content knowledge of the field of Cognitive Psychology.
- (2) lab time will give students first-hand experience in the research methodologies used in research in Cognitive Psychology.

## 5.0 REQUIRED TEXTS

Reisberg, D. (2018). *Cognition: Exploring the Science of the Mind*, Seventh Edition. Norton.

There will be additional required readings (journal articles, book chapters) assigned throughout the course.

**Suggested text:** *The Publication Manual of the American Psychological Association* (2009). (6<sup>th</sup> Ed.). Washington, DC: American Psychological Association

## 6.0 EVALUATION

1. Midterms (40%): There will be 4 midterm tests. They will be held through the year (see schedule for dates). Each midterm will be worth 10% of the final grade for the course. Midterm tests may cover any and all material (lectures, readings, activities, and discussion) covered since the last midterm.
2. Pop Quizzes/Mini-Assignments (4%): Each term, there will be a minimum of 3 pop quizzes and/or short assignments. Each will be worth 1% of the final grade (you may earn a maximum of 2% per term up to 4%). Quizzes and mini-assignments will be based on readings or activities scheduled.
3. Lab Projects (31%): There will be two lab projects, one per term. The first research project will be worth 11% of the final grade, and the second research project will be worth 20% of the final grade for the course. Details to be provided.
4. Final Exam (25%): The final exam will be scheduled by the Registrar's Office. The final exam will include what will essentially be the 5<sup>th</sup> midterm test as well as a cumulative (covering material over the entire course) essay question.

## 7.0 Huron Psychology Department Grading Policy

Students at Huron University College should consider a grade in the range from 70-74 to be evidence of satisfactory performance in a 2100-level Psychology course. Grades in the B+ (75-79) or A (80-89%) ranges will only be awarded for performance that is demonstrably superior to

the second-year standard associated with the Major or Minor modules. A grade of A+ (90-100%) will only be awarded very rarely and only for work that is truly exceptional.

## 8.0 Late Penalties, Extensions, and Make-up Tests

Make-up tests will not be allowed. If a test is missed for a legitimate reason appropriate documentation must be submitted in a timely fashion. For further details, see FASS Course Outline Appendix posted on OWL. If accommodation is granted, the remaining components of the evaluation will be re-weighted based on the remaining midterms. If more than 2 midterms are missed over the course, re-weighting will be at the discretion of the instructor.

All lab reports and assignments are to be handed in are due at the *beginning* of class on the due date (both electronic and hardcopy versions). Any items handed in after this time will be considered late. The penalty for lateness is 2% of the grade per day late (including weekends) up to 14 days late, after which the grade will be zero. Any extensions for legitimate reasons (see Appendix below) must be requested *before* the due date, and appropriate documentation submitted in a timely fashion. If accommodation is granted, an extension will be granted at the discretion of the instructor.

Note that due date extensions and re-weighting of a missed test will not be granted in order to facilitate travel arrangements (other than on compassionate grounds).

### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

### **Conduct of Students in Classes, Lectures, and Seminars**

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for a detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between Western University and Turnitin.com.

## **Computer-Marked Tests/exams**



Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

### **Clickers**

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else’s clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

**(b) Accommodation on Medical Grounds for assignments worth *less than 10%* of final grade: **Consult Instructor Directly****

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**(c) Non-Medical Grounds: **Consult your Instructor directly.****

Where the grounds for seeking accommodation are not medical, the student should contact the instructor directly. Late penalties may apply at the discretion of the instructor. Apart from the exception noted below, academic advisors will not be involved in the process of accommodation for non-medical reasons.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**Requests for Academic Consideration Using the Self-Reported Absence Form**

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

- a. students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- b. any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate (SMC)**, signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities. Please see section 4 below for more details.
- c. The duration of the excused absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;
- d. The duration of the excused absence will terminate prior to the end of the 48 hour period should the student undertake significant academic responsibilities (write a test, submit a paper) during that time;
- e. The duration of an excused absence will terminate at 8:30 am on the day following the last day of classes each semester regardless of how many days of absence have elapsed;
- f. Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;
- g. Self-reporting **may not be used** for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- h. students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.
