# **Course Description:**

This half-year course presents a survey of the Principles of Macroeconomics. In this course we look at the economy from an overall perspective, and address topics such as

fluctuations in the level of economic activity, unemployment, inflation, economic growth, the exchange rate, the banking system, monetary policy, and government fiscal policy.

# **Objectives:**

The course aim is to give students a grounding in the fundamental concepts of macroeconomics as they are used in making decisions both for business and policy makers.

At the end of the course students should be able to critically analyze the major economic events that occur on a day to day basis.

Students who are intending to pursue studies in business or political economy will gain the principles needed for further study.

# Methods:

This is an online course, with no synchronous lectures. It is however expected that your schedule is available for the purposes of this course (for example, to be able to attend office hours or write scheduled tests) during the official time slots assigned to this course (see Registrar's timetable for your section).

Although traditional "attendance" is not applicable to this course, it is expected that you will engage with the materials provided, complete all assigned readings and submit required work over the entire term.

A student who fails to maintain good standing (including satisfactory engagement) throughout the term may be prohibited from writing the final examination. (See the policy on Attendance Regulations for Examinations in the appendix).

# **Required Textbook:**

Parkin, Michael and Robin Bade, <u>Macroeconomics: Canada in the Global Environment</u>, 10th edition, Pearson, 2018.

The publisher sells this textbook physically or as an e-text, either may be bundled with MyLab. Older editions are extremely similar. Note that page references given in this course will be for the 10th edition.

# Supplementary Resources:

Although not required, supplementary practice resources are available for this textbook.

MyLab is the publisher's online learning tool with access to exercises and practice tests for each chapter in the text. Available separately or bundled.

The older editions of the study guide provide more appropriate practice for this course, but are out of print. The newest edition of the FlexText (2019) is less appropriate but may have some use so I have mentioned it.

# **Course Coverage:**

The course is organized in two-week units, typically covering two chapters each. Be aware that some parts of some chapters may by omitted or covered in a different order. Refer to OWL for specific readings for each unit. Coverage may be modified as the course progresses.

Unemployment and Inflation. (Chapter 5)

Economic Growth and its Causes. (Chapter 6)

Finance, Savings and Loanable Funds. (Chapter 7)

Money and the Banking System. (Chapter 8)

Exchange Rates and Balance of Payments. (Chapter 9)

Aggregate Supply and Demand. (Chapter 10)

The Keynesian Model and Expenditure Multipliers. (Chapter 11)

The Business Cycle, Inflation and Deflation. (Chapter 12)

Government Fiscal Policy. (Chapter 13)

Monetary Policy and the Central Bank. (Chapter 14)

Note that in older textbook editions the numbering begins with Gross Domestic Product as Chapter 20.

## **Evaluation:**

There are practice quizzes on OWL to be completed as homework for each of the six units every two weeks (details provided on OWL). You will also be examined on two midterms and a final. The course weights are as follows:

Homework Quizzes: 10% Midterm I (February 9): 25% Midterm II (March 16): 25% Final Exam: 40%

Midterm dates may be subject to change. If any adjustments are required for this course, they will be announced on OWL and a class email will be sent.

The final examination will be on a date set by the Registrar during the final examination period (April 14 to 30, 2020).

Be aware that courses may be subject to grade adjustments, up or down.

You may refer to physical notes during examinations in this course, however it is not intended that you will have time to look everything up.

Unfortunately not all technical issues can be verified or accommodated. Be sure to adhere to all recommendations for reducing your risk during any online testing.

There will be **<u>no make-up tests</u>** for missed mid-term examinations. If you fail to write a mid-term examination you will receive the mark of **<u>zero</u>**.

If the grounds are appropriate, including if the absence is covered by a valid self-reported absence, the weight of a missed midterm may be reallocated to the final exam. #### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

#### Conduct of Students in Classes, Lectures, and Seminars

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the

purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<u>https://www.turnitin.com/</u>).

#### **Computer-Marked Tests/exams**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

## **Clickers**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

## Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a selfreported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/Academic\_Consideration\_for\_absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

# **Requests for Academic Consideration Using the Self-Reported Absence Form**

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting or medical of extenuating circumstances:

- Students will be allowed **a maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a <u>Student Medical Certificate (SMC)</u>, signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

# Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

# (a) <u>Medical Grounds</u> for assignments *worth 10% or more of final grade*: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

University Senate policy, which can be found at,

<u>https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf</u>, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## (c) <u>Non-Medical Grounds</u>: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
