CGS1022F - INTRODUCTION TO GLOBALIZATION

Course Description: This course introduces and critically examines dominant approaches to understanding human interconnection at a global scale, and provides an interdisciplinary overview of various trends attributed to globalization.

Course Objectives: In this course you will become familiar with theories related to the phenomenon of globalization as a social, political, and economic development of late/high Capitalism. Students will explore the historical development of globalization in its myriad forms and in various contexts, providing a critical approach to the simplistic representation of either uniformly positive or negative effects of world-wide interconnections, and dependencies. Using case studies to analyze the ways that expanding trade and socio-political entanglements alter the dynamics of daily lives in different local contexts, this course will provide tools for the further interrogation of various global-local interconnections and the power dynamics that help shape them.

Course Methods: Online instruction will include short lessons and video lectures combined with self-directed study and mandatory discussion forums. Readings and films will be complemented by these forum discussions and the short lessons which will situate and contextualize the course materials, allowing students to take leadership over the shape of these efforts in the forums and the written assignments.

Assignment #1 – Film Analysis – Due October 2, 5PM EST – 10%

Angry Inuk OR Searching for Winnetou

Students will complete a film analysis of the either the documentary Angry Inuk or Searching for Winnetou. Papers should be 400-600 words, and should focus on analysis, not summary. Papers must include proper citations using MLA, APA, or Chicago style guidelines. Please use Times New Roman font, 12 point, double spaced. More instructions will be provided during the course.

Assignment #2 – Final Paper – Due November 30, 5PM EST – 20%

Students will complete an original research paper on a Community/Place where social change has been affected by global influences and the impact of economic globalization. Students will explore the history of a community or nation, their forced incorporation into the global economy and the implications of this Colonial/Capitalist hegemony on people's social, cultural and economic well-being, as well as local responses to this domination. More instructions will be provided during the course.

Papers will be 1200-1500 words, and must include proper citations using MLA, APA, or Chicago style guidelines. Please use Times New Roman font, 12 point, double spaced.

Weekly Discussion Forums – 40%

Students will participate in weekly forum discussions based on the course materials and short lessons introduced in class. Students should post at minimum two comments/posts per week (for 8 of the twelve weeks, therefore 16 total comments over the twelve week course, minimum). At the end of each three week set student's will nominate two of their own posts for grading, each

out of a possible 5 points (for a cumulative total of 40% of the final grade in the course). This will take the place of participation and attendance, and will offer an avenue through which to refine our close readings of critical texts, central themes and theories, and contemporary issues related to these ideas. The intention of the forum discussion is to help students stay on schedule with the readings and to allow for clarification of complex theories and ideas.

The purpose of the online discussions is to make the learning process interactive and collaborative: The discussions provide us with the opportunity to learn from and interact with each other and counts towards the participation aspect of the course. Every student must participate in the forums.

All students are required to make at least two (2) substantial contributions to the discussion forums each week (starting with week one, ending on week twelve). Not posting the minimum of two posts is the equivalent of missing the week, and students who post fewer than the minimum will forfeit the grades associated with that week of forum discussion. Since each set contains three weeks and each nomination includes only two posts students may "miss" one week out of each three week set without penalty.

The contributions should be well-developed comments and questions, not only two or three sentences, but no longer than three paragraphs (per contribution). I am looking for thoughtful, well-supported, clear, and coherent postings that make use of course materials. I will post a more thorough set of directions for forum postings on the OWL site in the first week.

Your postings must focus on issues addressed in the course readings and films, such as: comments on the readings and films; discussions of the concepts and theoretical approaches presented in the readings; questions that you think might be useful for reflecting on the arguments made by the authors; and critical reflections on your experiences with issues discussed in this course.

Your contributions can be original postings and/or responses to other participants' questions. "Original postings" refers to postings that are not branches from other messages, and they should include questions to facilitate discussions.

Final Exam – Date TBD during December Exam Period (Dec 11-22) (30%)

A final exam will be written at home in a "take home, open book" format. Students will answer both short and long answer questions, and should include references to course materials, properly cited. Students will have 36 hours to complete the exam from the time it is released, and will be expected to submit exams to OWL/Turnitin in an accessible format (.doc is best).

Prerequisite and Antirequisite Information

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is

subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

Computer-Marked Tests/Exams

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Clickers

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic policies/appeals/Academic Consideration for absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will
 require students to present a <u>Student Medical Certificate (SMC)</u>, signed by a licensed medical or
 mental health practitioner, detailing the duration and severity of illness, or appropriate
 documentation supporting extenuating circumstances to the Academic Counselling unit in their
 Faculty of registration no later than two business days after the date specified for resuming
 responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

(a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
