## **Course Description:**

This course will explore the political, economic, and social foundations of modern China through an examination of its modernizing experiences in the twentieth and twenty-first centuries. It will introduce students to questions arising from China's socialist and post-socialist development to investigate how China engages with the world with respect to its capitalist modernization, democratization, urbanization, shaping of national identity and gender, etc. The course will be taught in **English.**

## **Learning Objectives:**

- 1. Gain an overview of the economic, social, and political development of modern China;
- 2. Acquire a general understanding of contemporary Chinese studies;
- 3. Deepen the understanding of the relationship between China and the world;
- 4. Develop the skills of critical thinking and problematic consciousness.

## **Textbooks and Other Required Resources:**

Readings will be posted on the OWL site.

### **Class Methods:**

Classes are usually composed of my presentations, film/video clips screening, and students' presentation sections. Students are required to participate actively in each class.

### **Methods of Evaluation:**

Attendance and Active Participation: 10% 4 quizzes: 20%

Course presentations and Follow-up Paper 20% (10%+10%)

Midterm Test: 20% Final Exam: 30%

## **Attendance and Participation**

Attendance and participation do not simply mean that you attend all classes, coming to class on

time, and staying until the end. It is most important that you read the texts and come to class prepared. You must actively participate in the discussion and interact with the instructor and your fellow students.

## **Presentation and Report**

Students will sign up for the session that they plan to do their presentation. The presentation topics will be available on a first-come, first-served basis. In this presentation, you will explore the chosen topic in greater depth. You will do research that involves adding at least one additional reading relevant to the topic. The assigned readings are a good place to start. I am also happy to talk with you and give suggestions after class or during office hours. Please do not just do an uninformed internet search! In addition, please do not just provide some background information or knowledge for some issues. You need to develop a critical analysis of the chosen topic.

#### **Quizzes**

There will be 4 in-class pop-up quizzes worth 20% in total. You are free to refer to class handout, notes, readings, or any class materials. The questions of the quizzes will be based on class materials, including readings and lecture.

#### **Tests**

The mid-term test will take place in class on **Oct 20.** It is two hours in length and covers lectures and readings in the past sessions. The final exam will be scheduled during the exam period. It will cover lectures and readings after the mid-term test. The exam format will be given in class before the exam.

## **Film Screening**

You should consider the films as required texts and deal with these two films in the same way as you do with all class reading materials. Besides, there are short videos to be screened in other weeks.

### **Special Instructions:**

- 1. Once you sign up for your presentation, you cannot change your topic without the permission of the instructor. There will be no grade given in the case of no-show without prior notice.
- 2. There will be no make-up for the missed presentation, quizzes, and exams. Failure to complete your presentation, quizzes, and the two exams will result in a grade of zero without proper documentation. A student who misses the presentation, quizzes, or tests must provide documentation to the counseling office (not the professor). If this documentation is accepted as a valid reason for missing a presentation, quizzes, or tests, then (and only then) a make-up session will be considered. This is the only method of accommodation for missed sessions.

#### **Statement on Use of Electronic Devices**

## Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### **Academic Consideration for Missed Work**

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

#### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

## b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
