### **Trauma, Memory and Narrative in Chinese Literature and Film**

#### **Course description:**

Trauma is “a crisis of representation” (Hirsch). Trauma is “socially mediated” (Alexander). To understand trauma, it is not enough just to examine the incident that has caused the wound. More importantly, we should explore the way stories of traumatic experience are told. This course examines the narratives of traumatic experience in contemporary Chinese literature and film. Our focus will be on the representation of traumatic experience in selected historical episodes in modern Chinese history. Drawing on various approaches to trauma in film studies, literary criticism and social theories, we will analyze the portrayal of trauma in selected films, literary texts and memoirs. We will also investigate how historical trauma in the collective memories of the Chinese people shaped and reshaped the Chinese national identity, through popular conceptions and imaginations.

#### **Taught in English.**

Upon successful completion of this course, students are expected to

1. gain a general understanding of “trauma”;
2. have a general knowledge of approaches to “trauma” in film studies, literary criticism and social theories;
3. demonstrate basic skills for analyzing literature and film with reference to their historical, social and political contexts.

### **Online learning**

**Course work:**

Please be reminded that your final grade reflects your performance in this course. As the term begins, your grade is zero and will increase with the accumulation of your course work. Please read the following descriptions carefully and decided how to earn your grade.

**Zoom meeting attendance (10%)**

The zoom meeting attendance is calculated by hours attended divided by total zoom meeting hours. If you attend part of a zoom meeting (for example, half of a one-hour meeting), only the time of your attendance will be counted (for example, 0.5 instead of 1).

At the beginning of the term, your attendance grade is zero. It will grow with the accumulation of your attendance hours. Please note that if you miss a scheduled zoom meeting, there will be no penalty, but you will not earn the attendance for the hour.

The zoom meeting is a virtual classroom. In in-person classes, your presence in class means you are heard or at least seen by other students and the instructor. Likewise, you must show yourself in the zoom meeting. If your camera and mic is off throughout the zoom meeting, you will not be considered as present. In other words, to earn attendance grades, you, not just your name, should be in the zoom meeting.

**Reading/Lecture quizzes (10%)**

The quizzes will be posted in the subpage of the relevant unit in “Lessons.” Each quiz must be finished before the indicated deadline. After the deadline the quiz will be closed and **there will be no make-up for missed quizzes.**

**Class participation /Forum discussion (5% + 5%)**

It is assumed that you already understand the basic concepts of a university essay. If you are not familiar with the requirements for the essay structure, the thesis statement, etc., you might find the links for writing assistance helpful.

### **Prerequisite and Antirequisite Information**

Personal Response Systems (“clickers”) may be used in some classes. ### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

### **Requests for Academic Consideration Using the Self-Reported Absence Form**

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a [Student Medical Certificate \(SMC\)](#), signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.

- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

- (a) **Medical Grounds for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email [huronsss@uwo.ca](mailto:huronsss@uwo.ca) .**

requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

- (b) **Accommodation on Medical Grounds for assignments worth less than 10% of final grade: Consult Instructor Directly**

When seeking accommodation on medical grounds for assignments worth less than 10% of the

final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising**

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed [Accommodation Request Form](#). Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
