### **2. Course Description**

This course studies the problem of scarcity and its implications in firms' and consumers' choices. We will learn how preferences, constraints and prices affect consumers decisions. For firms, we will examine how input and output prices and technologies affect production decisions. As we put together the consumers and producers in a model, we will go over how market prices and quantities are determined in different market structures (competitive, monopoly, monopolistic competition and oligopoly). The effects of different public policies will be examined.

### **3. Course Learning Outcomes**

- Students will understand how consumers and producers make their optimal decisions under different market structures.
- Understanding how market works, students will be able to analyze how different policies would impact different groups in the economy.

### **4. Textbooks and Course Materials**

### **5. Methods of Evaluation**

- 10% Assignments

Assignments:

Sets of questions are to be submitted and will be graded. Approximately, there will be one graded assignment per chapter. The due dates of these graded assignments will be approximately one week after the respective chapter is covered in lectures.

Examinations and Assignments:

All examinations (midterms and final) and In-class Assignments will ask multiple choice questions and long questions, where students are expected to give comprehensive written responses incorporating calculations and graphs to support their answers.

Note: There will be no make-up assignments or tests. If you fail to complete an assignment or write an examination, you will receive a mark of zero. Should you miss a mid-term examination or an assignment for a legitimate reason, such as a serious illness, the marks allotted to the missed portion can be reallocated to the final examination in this course subject to approval by the Dean's Office. It is your responsibility to request such a reallocation and to provide appropriate documentation to support the request. This documentation must be taken to an Academic Advisor in the Academic Counseling Office for approval by the Office of the Dean.

Personal Response Systems (“clickers”) may be used in some classes. ### **Policy on Academic Consideration for a Medical/ Non-Medical Absence**

- (a) Consideration on **Medical Grounds** for assignments worth *less than 10%* of final grade:  
**Consult Instructor Directly and Contact Academic Advising**

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the [Student Medical Certificate](#). The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

**b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising**

University Senate policy, which can be found at [Academic Calendar - Western University \(uwo.ca\)](#) requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: [https://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/medicalform.pdf](https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf).

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation.
