### **Course Description:**

This course provides a critical survey of the social, economic, religious, and political experience of the Jewish people and their precursors from the biblical period until the Spanish Expulsion. The course will cover a wide variety of topics and will focus on three principal themes: (1) how we know what we know about Jewish history; (2) the ways in which Jewish life was influenced by the cultures in which particular Jewish communities lived; and (3) the ways in which there is continuity and commonality among Jewish communities no matter the time and place of these communities.

# **Course Learning Objectives:**

Students who successfully complete this course will be able to:

- identify key events, persons, places, and works in Jewish history;
- relate these facts to the larger cultural and political contexts in which they took place;
- describe continuities in Jewish life regardless of region or time period;
- analyze primary sources and understand what they tell us about Jewish history;
- formulate clear and analytic arguments in written work and presentations based on primary and secondary sources.

## **Description of Class Methods**

Class methods will include lectures, weekly quizzes, weekly exercises on primary sources and issues, and class discussion. Students are expected to have completed the readings for each session before the session, to participate in class discussions, particularly in weekly exercises on primary sources, and to complete the weekly quizzes in a timely manner.

John Efron, et al, *The Jews: A History*, 3<sup>rd</sup> ed. (Boston: Routledge, 2018) Other readings will be available on OWL or in the Tanakh (Jewish Bible), the second Jewish Publication Society version of which is available online at sefaria.org

Grades will be based on weekly quizzes and the mid-term chronology quiz, weekly classroom exercises on primary sources, one exam, and two papers designed to develop students' ability to analyze primary documents and integrate them into broader historical narratives. A primary source will be suggested for each assigned paper. Student may choose a different primary source only with prior approval from the instructor. The primary text analyses will be a more in-depth analysis of the type done for the weekly exercises on primary sources. The papers are due on the schedule set forth below.

Someone from Library & Learning Services will come to class on Thursday, September 15 and Thursday, October 20 to provide training on research methods for the primary source analysis papers. These training sessions will provide significant guidance on successful analysis of primary sources.

Please complete the readings for each session before the scheduled time for that session. For the Tuesdays that we meet in person, students will have about 10-15 minutes of class time to complete the quiz. The quizzes are open-book, but you will need to be familiar with the material in order to complete the quiz successfully.

Note the following exceptions to the quiz schedule:

- 1) The Quiz for the first day of class is due Thursday, September 8 at 8:00 am. Please submit via OWL BEFORE reading any of the assigned readings. Everyone who submits a thoughtful answer by the deadline will receive full credit of 1% of the total course grade.
- 2) Tuesday, September 27, Tuesday, October 11, and Tuesday, October 18 are Jewish holidays. We will not meet in-person on those days. On those weeks, the quiz will go live on OWL on Sunday morning of that week at 8:00 am and will close on OWL at 3:00 pm on Wednesday of that week. For the quiz on Tuesday, September 27 and on Tuesday, October 11, you should watch the online lecture noted on the syllabus, in addition to the reading, before taking the quiz.
- 3) The Mid-Term Chronology Quiz is on Thursday, October 20 at the start of class. You will have up to 30 minutes to complete the quiz. It is open-book, but you will need to be familiar with the chronology of the material covered to that point to complete the quiz successfully. The Mid-Term Chronology Quiz is worth 2% of the total course grade.

If necessary, make-up time will be offered for up to 30 minutes on the last day of class, Thursday, December 8, 2022.

Evaluation on weekly classroom exercises on primary sources will be based on participation and insights into the significance of the primary source for understanding Jewish history. Participation each week is worth 1% of the total course grade.

Primary Source Analysis #1 is due Thursday, October 6 at 12:00 noon via OWL. Primary Source Analysis #2 is due Thursday, November 10 at 12:00 noon am via OWL. The final examination will be posted to OWL on Dec. 8 after the last class ends. The final examination will be scheduled by the Registrar's Office and is to be completed and submitted via OWL. It is a takehome, open-book exam. Please use your course materials to complete the questions.

The Primary Source Analyses must be typed, double-spaced, using 1" margins, and 12-point font. Each paper must be between 1,300 and 1,600 words.

Papers handed in late will be penalized one full letter grade if submitted within one week of the due date. Papers will not be accepted after that time. Exams will be taken as scheduled. Any exceptions will be pursuant to the Western Policy on Accommodation for Medical Illness.

# **Statement on Use of Electronic Devices**

# Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
