As a member of the Business School Association of Canada, Huron offers Management and Organizational Studies (MOS) programs that explore all areas of business and how organizations operate. Prepare for a career as an accountant, banker, business consultant, economist, entrepreneur, project manager, logistics specialist, marketer, or market researcher. The MOS degree provides a foundation for business careers and is a strong stepping-stone toward professional designations such as the CPA and CFA.

Customize your Degree

Combine modules like specializations, majors, and minors to build a path that matches your passions and goals.

Management & Organizational Studies ▲

This program is for students who want to achieve competency in business and pursue another area of study.

Finance and Administration ●◆

This program is for students interested in a career in the financial sector. Study markets, trade, and financial decision-making, with an emphasis on the economic principles driving them.

Marketing & Sustainability ●◆

This program is a quickly emerging field, students learn about the business of promoting, advertising, and consumption behaviors while lowering harm to the environment and ethically and equitably increasing the quality of life and well-being, presently and for future generations.

Business Intelligence ●◆

This program is a fast-emerging field in Canada and around the world. It covers core components in data analytics, database management, data visualization, predictive machine learning, and more.

Accounting ●◆▲

This program is for students who want to lay the groundwork for future accountancy studies and still pursue another subject interest.

Organizational Studies, Policy, and Ethics ●◆

This program combines a study of business with broader contexts for practices in law, politics, governance, and ethics.

Beyond the Classroom

Huron's MOS program partners with the community to integrate real-world experiences as a core component of each learner's degree. In a growing number of offerings, course content is directly linked to practical applications. Recent examples include:

- Teams of students working as consultants with actual clients on real-world business problems. Local organizations included London Film Festival, Canadian Commercial Real Estate, rTraction, L'Arche, Thames Tire, among others. In previous years, another 20-plus clients were served, including Life*Spin, Nash Jewellers, Hog Town Cycles, the London Small Business Centre, Clarendon Technologies, and Oxford Learning Centre.
- The Business-Government Relations Class worked with Music London, where student teams competed with a 3-minute pitch competition for the best marketing strategy proposal.
- The Organizational Governance class worked with Museum London, Youth Opportunities Unlimited, Across Languages, London Environmental Network, and Pillar Non-Profit to provide consultancy services.



CAREER INTERNSHIPS

Get paid part-time experience during the school year or full-time in summer. These roles align with your interests and help build your resume with real-world value.

ACADEMIC INTERNSHIPS

Earn while you learn. Take 4–16 months off between Year 3 and Year 4 for a full-time, for-credit, paid internship. Many students receive job offers after completion.

RESEARCH INTERNSHIPS

Work with a Huron faculty member for support on a student research fellowship with funding up to \$1,500 or a paid research assistant opportunity.

ENTREPRENEURIAL INTERNSHIPS

Get support to ideate, plan, and launch a new business. You'll get 1:1 coaching, access to funding, and other resources to set you up for success.
