# Description

We humans are, in the familiar ancient slogan, "rational animals". Yet there are systematic problems with the way we reason — routed in unconscious biases, fallacies, illusions, inconsistencies, misinformation and a multitude of intellectual vices.

The goal of this course is to help us get better at mitigating these cognitive shortcomings and, in turn, enhance our ability to reason. We pursue this aim with an eye towards forming more accurate beliefs and making better decisions.


#### Methods

Teaching methods will involve pre-prepared slides, with brief recordings, and live virtual class discussions (e.g., tutorials, workshops and various exercises).

# **Text**

There is no textbook for this course. All readings will be made available via OWL.

# **Technical Requirements**





This fully online course will contain a mixture of synchronous and asynchronous learning methods. All synchronous (i.e., live Zoom) sessions will take place at the Tuesday and Thursday start times above. Zoom meetings will\_never last a full 3 hours. As an alternative, students will be given material to prepare for those sessions, asynchronously, at their own discretion. Weekly checklists and a Zoom schedule will be made available on OWL. Lastly, if you are working outside of Huron's local time zone, and are unable to attend our Zoom meetings, please see the red note below (p. 2).

#### Aims

By the end of term, every committed student will know how to do four things:

- 1. categorize, diagram and assess arguments from virtually any discipline,
- 2. spot and, to some extent, mitigate common forms of human irrationality (e.g., biases, fallacies and inconsistencies), and the various harms they can cause,



- 3. look for good sources of information and distinguish these from bad sources
- employ various techniques and principles for rationally updating their beliefs (SKILLS) (KNOWLEDGE, 1-4),

#### Students will also get opportunities to

5. construct intellectual rules or guidelines that improve their thinking and decision-making (PERSONAL DEVELOPMENT).

**Participation:** Good philosophy requires conversation. Consequently, in addition to prepared materials/ slides/recordings that you will review on your own time, this course contains weekly live sessions which will take place over Zoom. Every student is expected to submit one (1) written answer (1-2 sentences) to a weekly Forum Q. Forum Qs must be accessed— and answers must be submitted—within the small classroom window that is provided. No exceptions. Students will also be rewarded for their verbal contributions, which will take place in relaxing (i.e., small group) settings.

• Note: if you are working outside of Huron's local time zone, and are unable to attend our live online sessions, please note this in OWL's DropBox, <u>during the first week of class</u>, by simply writing "Opt-Out Request for Online Participation and/or Podcast" in the subject title. I would be pleased to fully accommodate you for missing assignments 1 and/or 4, upon request. Please indicate your choices in DropBox.

**Podcast:** For this assignment, you will work, virtually, in small groups, including a moderator, that your instructor will assign. After receiving instructions and a group number, each group will record a video (or audio) podcast, over Zoom, and submit it for a grade. See schedule below. Detailed instructions will be provided via OWL. **Note:** if you are uncomfortable with facial presentation, you may mute your webcam. Also see the red note above.

**Rules assignment:** This assignment is designed to encourage you to think carefully about how to think better in the midst of applying course techniques and concepts. You will be constructing your own concrete rule(s) for mitigating bias and/or avoiding common fallacies. Detailed instructions, with a sample assignment, will be provided via OWL prior to the deadline.

**Exam:** To take place in June (date: TBA). As this exam will be be "open book", and written from home, its purpose is to test the student's understanding of major themes, arguments and positions etc. As answers to such questions cannot be unreflectively pasted from the slides, advanced preparation is strongly recommended.

All written assignments, including your exam, must be submitted through the assignments tab (on OWL).

#### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

#### **Statement on Use of Personal Response Systems ("Clickers")**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

## **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_illness.pdf are met.

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. ### Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# (b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <a href="Consideration Request Form">Consideration Request Form</a>. Late penalties may apply at the discretion of the instructor.
