# 2.0 CALENDAR DESCRIPTION

This course is designed to provide students who have a credit in Psychology 1000 or equivalent with the laboratory experience that is part of Psychology 1100E but not Psychology 1000. Successful completion of Psychology 1000 plus 1001E will be accepted as the equivalent of credit in Psychology 1100E for purposes of entry into courses and modules at Huron.

Antirequisite: Psychology 1000W/X, Psychology 1010A/B, Psychology 1015A/B, Psychology 1100E.

Unless you have either the prerequisites for this course or written special permission from your Dean to enroll in the course, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

#### 3.0 COURSE DESCRIPTION

An introductory survey of the methods and findings of modern scientific psychology. The following topics will be covered: history and methodology, biological psychology, sensation and perception, learning and motivation, verbal and cognitive processes, developmental psychology, social psychology, individual differences (intelligence and personality), and clinical psychology.

A grade of at least 60% in Psychology 1000 is a prerequisite for most senior Psychology courses offered at Western (Main campus, King's, and Brescia). Note that entry to the Huron Psychology program requires Psychology 1100E, and Psychology 1000 is not a substitute for Psychology 1100E and without supplementation will not provide entry to the Psychology program at Huron, nor the majority of senior courses in Psychology offered at Huron. #### 10.0 POLICY REGARDING MAKE-UP TESTS

- 1. If you are unable to write a scheduled test, please inform your instructor and your Academic Advisor via email prior to the scheduled due date and time of the test.
- 2. You will be required to provide acceptable supporting documentation for your absence from the original test before accommodations will be granted. This documentation must be presented to the Academic Dean's Office; please see the next page (page 9) of this outline for information on acceptable forms of documentation. Discuss with the instructor if and when the test can be rescheduled or reweighted. The method of accommodating for the missed test will be up to the discretion of the instructor.

#### 11.0 MAINTAINING COURSE INTEGRITY

The instructor takes academic integrity very seriously. As such, during the course several strategies will be employed, where applicable, to limit academic dishonesty, such as checking ID during inperson tests, using Turnitin for submitted assignments and non-linear question presentation in OWL test. Other techniques may also be employed as they become available and/or necessary. For example, as noted above, no assignments will be accepted if submitted via methods known to assist in cheating (e.g., WeChat). Please note, that any acts of academic dishonesty will be taken very seriously. As a student, if you become aware of any instances of academic dishonest, you are strongly encouraged to discuss these with the instructor.

#### OTHER ISSUES

#### SHORT ABSENCES

If you miss a class due to a minor illness or other problems, please check your course outline for information regarding attendance requirements and make sure that you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate; professors can't give personalized lectures for students who miss class. (If you miss class for a legitimate reason – e.g., a death in the family, illness – Dr. Gorman would of course be pleased to answer questions during office hours after you have borrowed and reviewed lecture notes from a classmate.) Connect with your group members as soon as you can to explain what happened and find out what you missed and what your responsibilities are.

#### **EXTENDED ABSENCES**

If you are absent for more than approximately two weeks, or if you get too far behind to catch up, you may need to consider reducing your workload by dropping one or more courses. The Academic Counsellors can help you to consider the alternatives. At your request, they can also keep your instructors informed of your difficulties.

#### **DOCUMENTATION**

**In case of personal illness:** As indicated in the university's Policy on Accommodation for Medical Illness, if documentation is required for either medical or non-medical academic accommodation, then your documentation must be submitted by the student directly to the appropriate Faculty Dean's Office and not to the instructor. It will be the Dean's Office that will determine if academic accommodation is warranted.

**For other extenuating circumstances:** If you are not sure what documentation to provide, please ask your instructor or an Academic Counsellor.

**Note.** Forged notes and certificates will be dealt with as a scholastic offense (see below) and you will be subject to academic sanctions.

# PROCEDURES FOR APPEALING ACADEMIC EVALUATIONS\*

The grounds for an appeal may be one or more of: medical or compassionate circumstances, extenuating circumstances beyond the appellant's control, bias, inaccuracy, or unfairness. All grounds must be supported by a clear and detailed explanation of the reasons for the appeal together with all supporting documentation.

In the first instance, all appeals of a grade must be made to the course instructor as soon as possible after a mark is issued (informal consultation). In the event that the student is not satisfied with the decision of the course instructor, or if the instructor is unavailable to the student or fails to act, a written appeal must be made to the Department Chair. The deadlines for appeals to the Department Chair are January 31 for Fall Semester marks and June 30 for Winter Semester marks. If the response of the Department is considered unsatisfactory to the student, he/she may then appeal to the Dean of the Faculty in which the course or program was taken (with submission of written request). Only after

receiving a final decision from the Dean may a student appeal to the Senate Review Board Academic. A Guide to Appeals is available from the Ombudsperson's Office.

Any remaining assessments will also be conducted online at the discretion of the course instructor. #### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. # Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

# **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. # Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

(b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <a href="Consideration Request Form">Consideration Request Form</a>. Late penalties may apply at the discretion of the instructor.
