**Delivery**

This course will be taught online, making use of the interactive Zoom platform. Classes will run live on the days and at the times indicated. The point of using Zoom is to make the course a *distance* course, so that students will access lectures not on the campus, but from wherever they happen to be. On the other hand, **the Zoom lectures will not be recorded**, and so students will be expected to view and listen to the lectures at the times originally scheduled in Western's Intersession timetable.

**Description**

The objective of this course is to familiarize students with a number of different problem areas associated with the growth of economic globalization since the mid-20th century. Topics will include: the nature of obligation; the idea of international justice; global poverty; the tension between liberal universalism and national sovereignty; human rights; resource distribution; international trade; health and healthcare; and international migration.

**Objectives**

Students will learn to assess the comparative seriousness of the philosophical problems that arise in connection with these phenomena. In addition, they will develop the skills to make comparative assessments of various solutions to these problems offered by philosophers working mainly in the last 40 years or so, and by doing so, gain a basic knowledge of many of the central themes that appear in the interplay between thinking about economic phenomena associated with globalization on the one hand, and problems about social justice, on the other.

**Course Method**

Lecture; with professor/student and student/professor question/answer exchanges.

## Assessment:

Remember that this is a 'distance' course, so recordings of the classes will not be made, and students will be expected to use Zoom to access the individual classes at the time when they are officially scheduled.

Keep this in mind when you read the following paragraph.

In the running of the course, there will be three Thursday classes. On each of the three Thursdays, students will have to write an open-book, essay-style test. They will have to do this on camera, in the same way that they would be on camera in a participatory, gallery-format Zoom class. Students will be expected to have the textbooks in front of them, so that they can consult it; but they will be barred from using other sources, including other computers or telephones. Students will have to be on camera continuously as they write.

The testing will not be cumulative, so that once a certain portion of the course material has been tested, there will be no further testing on the fact portion of the course material

Students' grades will be determined on the basis of **three short essay tests for which no outside research is required** – each 4-5 pages in length, and **each worth 33%** – for a total of **99%**. Each student will get one bonus mark, bringing the total to a possible 100%.

### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<http://www.turnitin.com>).

### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

### **Statement on Use of Personal Response Systems (“Clickers”)**

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else’s clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

### **Academic Consideration for Missed Work**

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

### **Policy on Academic Consideration for a Medical/ Non-Medical Absence**

- (a) **Consideration on Medical Grounds for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising**

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to

the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the [Student Medical Certificate](#). The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

**b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising**

University Senate policy, which can be found at [Academic Calendar - Western University \(uwo.ca\)](#) requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: [https://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/medicalform.pdf](https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf).

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

**c) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email [huronsss@uwo.ca](mailto:huronsss@uwo.ca).**

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed [Consideration Request Form](#). Late penalties may apply at the discretion of the instructor.
