### Course Description:

This course introduces students to the scholarly mission, foundational knowledge, and learning pathways in the study of Governance, Leadership and Ethics (GLE) at Huron University. As a multi-disciplinary field of study, the GLE Major explores new ideas and innovative approaches to tackling the most complex societal and community challenges of the 21st century. These include climate change, economic inequality, digital transformation, systemic discrimination, and public health. Such challenges are deep-seated and cross-cutting and cannot be solved by any single actor, organization, or country on its own. In an age marked by profound polarization, amplified by technology and media, the GLE considers the “common good”, asking whether or how societies produce collective solutions to shared urgent challenges.

### Learning Outcomes: one outcome per entry

provide students with foundational knowledge that informs the contemporary study of governance, leadership and ethics, positioning them for success through the GLE Major. It will introduce students to both theoretical concepts and empirical applications, providing guidance in case study research.

challenge and support students intellectually in analyzing complex public problems that cross disciplinary and organizational boundaries, and evaluating the factors that enable productive collective action.

provide opportunities for students to learn about “knowledge co-creation” through group projects that combine disciplinary perspectives and connect classroom learning to ‘real world’ problems defined by actors in public, private, and community contexts.
